- 2. Maximum loanable amount is P50,000.00;
- 3. The following documentary requirements must be complied with:

2. Two (2) original copies of 2 months payslip with photocopy,	
3. Two (2) original copies of Authority to Deduct with signature over printed name,	
4. Two (2) original copies of Disclosure Statement with signature over printed name, and	
5. Two (2) photocopies of latest valid ID's with clear signature.	
6. Photocopy of school assessment form or any proof of enrolment.
